CREDITS

Upon completion of the academy, students are eligible for 40 hours of continuing law enforcement units (CLEUs) or continuing education units (CEUs) for many of the disciplines involved in the academy. You may also take NEVAA for three undergraduate course credits through Creighton University or University of Nebraska at Kearney with proper registration, completion of the academy and any additional course requirements. Creighton University tuition is reduced to UNK's tuition rate.

NEVAA is a pre-approved "A" level training with the National Advocate Credentialing Program (NACP) for those who are interested in national victim advocate accreditation. You can find more information at trynova.org/help-crime-victim/nacp/.

This course meets the Board of Mental Health and Social Work requirements for continuing education in the state of Nebraska. Credits are self-reported.
